1. Statement for recovery of ST amounting to **Rs. 6,08,91,351/-** as per Annexure 'A' for **FY 2013-14** from **M/S Housing Board Haryana, Plot No. C-15, Sector-6, Panchkula** (hereinafter referred to as **the noticee**) u/Section 73(1A) of the Finance Act, 1994 reproduced below:

"73[(1A) Notwithstanding anything contained in sub-section (1), the Central Excise Officer may serve, subsequent to any notice or notices served under that sub-section, a statement, containing the details of service tax not levied or paid or short levied or short paid or erroneously refunded for the subsequent period, on the person chargeable to service tax, then, service of such statement shall be deemed to be service of notice on such person, subject to the condition that the grounds relied upon for the subsequent period are same as are mentioned in the earlier notices.]"

2. **The noticee**, were served an SCN issued vide C. No. V(ST)15/101/ST-Adj/PKL/2014/7989 dt 21.10.2014 for Rs.60,40,66,724/- for FY 2009-10 to 2012-13 by the Principal Commissioner, CX & ST Commissionerate, Panchkula which is pending adjudication

3. For the subsequent period of FY 2013-14 also, ST of Rs. 6,08,91,351/- is short paid on identical grounds as already contained in earlier SCN issued vide C. No. V(ST)15/101/ST-Adj/PKL/2014/7989 dt 21.10.2014


4. Now, therefore in exercise of powers conferred upon me by virtue of Section 73 (1A) of the Finance Act, 1994, the undersigned issues this statement (deemed to be Notice on the same grounds) to the Noticee calling upon them to show cause in writing to the Principal Commissioner, CX & ST Commissionerate, Panchkula, SCO 407-408, Sector-8, Panchkula, within 30 days of the receipt of this statement (Notice), as to why:

- (i) ST amounting to **Rs. 6,08,91,351/- (including cess)** as per Annexure 'A' for the period 2013-14 should not be recovered from them u/Section 73 of the Finance Act, 1994 along with interest u/Section 75 (ibid) and
- (ii) Penalty should not be imposed upon them u/Sections 76, 77 & 78 (ibid)

5. The Noticee are further directed to produce at the time of showing cause all the evidence, documentary or otherwise, upon which they intend to reply in support of their defence. The Noticee should also indicate in their written reply as to whether they wish to be heard in person or through their authorized representative. If no mention is made about it, it will be presumed that they do not desire any personal hearing. Further, if no cause is shown against the action proposed to be taken, within the stipulated period or the Noticee or their legal authorized representative does not appear before the Adjudicating Authority when the case is posted for hearing, the case would be decided ex-parte on the basis of evidence already available on records.
6. This Statement is being issued to the Noticee without prejudice to any other action that may be taken against them under the Act or the Rules made there under or any other Law for the time being in force in India.
